5. Responsibility of Participating Asatidz:

- Attend all sessions of the 10-day competent enhancement activity.
- Must strictly follow the schedule/s of the activity/ies as prescribed by the implementing regional office until he/she finishes the activity/ies.
- Prepare the necessary requiremnts needed for LET.
- Once passes, the asatidz shall be given the Teacher 1 item based on D.O.
 30, s. 2012 and shall teach ALIVE and DepEd prescribed subjects in elementary.
- Should the astidz fails the LET, he/she must render return service to DepEd based on applicable rules and regulations.
- The grantee shall always inform and seek permission from DepEd Division/School where he/she is deployed on matters pertaining to his/her involvement in the training and must always abide by the rukes of the DepEd.

6. Availability of Funds/Source of Funds:

- The budget shall be charged against downloaded funds to the region through the Madrasah Education Program Funds 2018.
