 (SHS-TVL) TEACHERS OF DEPED RO IX, ZAMBOANGA PENINSULA
 (TVL-TEC-TM1) (Batch 4)**

This refers to **DM-OUHROD-2024-1146** titled, "**BATCH 4 TRAINING ON TRAINERS METHODOLOGY LEVEL 1 FOR SHS-TVL TEACHERS**", which is currently conducted at Mibang Hotel- Mibang, Dipolog City on November 17-27, 2024 (Phase 1 -F2F), November 28-December 15, 2024 (Phase II-Online) and December 16-20, 2024 (Phase III-F2F).

Teaching and non-teaching personnel attending the said trainings (Phase 1 - III) shall be granted service credits if the activity which falls on a holiday, Saturday and Sunday pursuant to the guidelines in **DepEd Order No. 53, s. 2003** (Updated Guidelines on Grant of Vacation Service Credit of Teachers) and Compensatory Time-Off (CTO) per **CSC-DBM Joint Circular No.2, s. 2004** (Non-Monetary Remuneration for Overtime Services), whichever is appropriate and applicable.

Moreover, attached Annex A is the list of replacement participants and member of Technical Working Group (TWG).
