SCHOOL TEACHERS AND STUDENTS**

This has reference to unnumbered DepEd Memorandum signed by Atty. Fatima Lipp D. Panontongan, Undersecretary and Chief of Staff, dated August 20, 2025 re: **Request for support and participation on the West Philippine Sea Transparency Group (WPSTG) Regional Engagements with Public School Teachers and Students** for the conduct a regional engagement activity to promote maritime awareness and strengthen public understanding of West Philippine Sea (WPS) issues on **October 25, 2025** in Zamboanga City.

The activity includes the **Film Screening** of the documentary "Food Delivery: Fresh from the West Philippine Sea" for Social Studies Teachers and selected students followed by a **Seminar-Workshop** on the WPS specifically designed for Social Studies teachers.

The venue for the Film Screening is at **KCC Mall Theater**, while the Seminar-Workshop for social studies teachers will be conducted at **Western Mindanao State University Gymnasium**, Zamboanga City.

The participants to this activity are **300 Social Studies Teachers**, for both film screening and seminar-workshop, and **100 students** for film screening, all are coming from **Zamboanga City Division**.

Anent this, it is further advised that Zamboanga City Division through the Education Program Supervisor incharge in Araling Panlipunan to prepare a list of participants for both students and teachers and submit the same to the WPSTG for the preparation of certificates and other necessary documents.

Transportation expenses, per diems and other incidental expenses of teacher-participants and students shall be charged against local funds/School MOOE all are subject to the usual government accounting and auditing rules and regulations.
