

All other provisions stated in the said Regional Memorandum shall remain in effect.



DATE : October 3, 2025

In line with the Department of Education's (DepEd) mandate of ensuring a safe and motivating learning environment¹, this Office through the Bureau of Learner Support Services – Learner Rights and Protection Division (BLSS-LRPD) initiated the *Introduction and Consultation of the Safe School Program*.

The proposed program is in partnership with the Child Protection Network (CPN) who developed the Teaching Module for Safe School, with the aim of inculcating help-seeking behaviors and understanding learners' emotions and actions. These materials are intended for Grades 7 and 8 and may be applied to secondary grade levels.

Accordingly, in strengthening our advocacy of ensuring a safe and motivating learning environment, the LRPD proposed to lead on the discussion and consultation to:

- Identify gaps or additional areas to be addressed
- Ensure the modules' alignment with our advocacy or protecting our learners' rights, and
- Develop the learners' socio-emotional skills
- Develop a re-entry plan for the possible implementation of Safe School

For this purpose, the LRPD requests the assistance of the Regional Offices to identify four (4) representatives which may be School Heads, Division and Regional Focal, and/or Registered Guidance Counselors. The participants are greatly encouraged to bring their own laptop for which shall be needed in the development of lesson exemplars based on the teaching module for safe school program.


