SUBJECT : Celebration of the National Volunteer Month in December 2025

DATE : 12 November 2025

I. RATIONALE

The culture of volunteerism is a proud legacy of the Filipino people and a testament to the "*bayanihan*" spirit. Volunteers play a critical role in development, contributing their time, effort, and resources to those in need, ultimately improving the quality of life for individuals and communities.

In recognition of the tireless efforts and dedicated service of volunteers, the Philippine Government declared the month of December as the National Volunteer Month (NVM) through Presidential Proclamation No. 55, series of 1998 (Annex A). This annual celebration honors efforts of volunteers and strengthens volunteerism as a vital force for inclusive and sustainable development.

II. PURPOSE

This Memorandum Circular enjoins all government agencies, local government units, and academic institutions to actively participate in the observance of the NVM 2025. The celebration serves as a common platform to highlight volunteerism as a key enabler of national and local development.

III. OBJECTIVES

The NVM celebration aims to:

- Build nationwide public awareness and appreciation of volunteerism and its role in social, economic, and political development of the country;
- Create an environment that fosters and encourages voluntary action for development; and
- Recognize the noble acts of volunteerism by individuals, families, institutions, and communities as vital partners in economic and community development.

IV. THEME FOR 2025-2026

***"Volunteerism for Inclusive Development: Empowering Communities Toward a Just and Resilient Future"***

## V. SUGGESTED ACTIVITIES

To promote participation and awareness, agencies, organizations, and institutions are encouraged to undertake the following activities:

- **Information and Advocacy.** Disseminate NVM information through display of banners and posters; posting of announcements; and sharing of the NVM 2025 promotional materials via official publications, bulletin boards, social media platforms (using the hashtag #NVM2025). Materials may be accessed through <https://bit.ly/NVM2025COLLATERALS>.
- **Engagement Activities.** Organize or participate in forums, volunteer fairs, community service projects, and other advocacy events aligned with the NVM theme, before and during December 2025. Updates on official NVM activities will be posted on the PNVSCA Facebook page. Interested agencies or institutions are encouraged to accomplish the online participation form accessible through <https://bit.ly/NVM2025PARTICIPATIONFORM> (Annex B).
- **Recognition and Sharing of Good Practices.** Highlight and document volunteer initiatives and best practices through awards, feature stories, and reports showcasing the contributions of volunteers and partners.

## VI. FOCAL AGENCY

The Philippine National Volunteer Service Coordinating Agency (PNVSCA) serves as the focal agency and secretariat of the NVM.

## VII. COORDINATION OF ACTIVITIES AT THE NATIONAL LEVEL

The PNVSCA is supported by the NVM Steering Committee (NVM-SC) in the planning, advocacy, and implementation of NVM events and activities. The NVM-SC is composed of the following:

### VIII. COORDINATION OF ACTIVITIES AT THE REGIONAL LEVEL

To ensure broader participation and more effective implementation of the NVM activities, NVM Regional Committees (NVM-RCs) are organized to coordinate and oversee celebrations at the regional level. The NVM Regional Committees (NVM-RCs) are organized and chaired by the following:

- DEPDDev Regional Offices (DROs) in the regions;
- Metropolitan Manila Development Authority (MMDA) in the National Capital Region; and
- Bangsamoro Planning and Development Authority (BPDA) for the Bangsamoro Autonomous Region in Muslim Mindanao (BARMM).



### IX. SUBMISSION AND SHARING OF ACTIVITIES

The conduct of NVM activities by national government agencies, government-owned and -controlled corporations, and state universities and colleges operating at the sub-national level is also in pursuit of Regional Development Council resolutions promoting volunteerism as a strategy of development.

Additionally, CSC Memorandum Circular No. 23, s. 2012 enjoins all heads of agencies to establish volunteer programs on top of the agencies' regular mandate and function to promote the value of volunteerism in the public sector.

# IMPLEMENTING GUIDELINES FOR THE CELEBRATION OF NATIONAL VOLUNTEER MONTH (NVM)

## 1.0 Policy Basis

Volunteers play a vital role in community development. Imbued with the spirit of goodwill, they offer freely their services to the community without expecting any financial gain.

In recognizing the volunteers and their contributions to society, President Joseph Ejercito Estrada issued Proclamation No. 55 dated 5 December 1998 mandating the celebration of National Volunteer Month (NVM) in December of every year under the auspices of the Philippine National Volunteer Service Coordinating Agency (PNVSCA).

## 2.0 Rationale

Volunteers are valuable players in the implementation of development initiatives. Many Filipino men and women carry out the tasks of information dissemination, community education, skills building, entrepreneurship, resource mobilization, people organizing, project monitoring, delivery of social services, small infrastructure development and many others to help empower people and increase their participation in local development.

The convergence of community volunteers to achieve a common goal tends to unify civil society. It is volunteerism manifested by "bayanihan" that holds together the Filipino people in times of crises brought about by natural or man-made calamities.

Volunteerism traverses boundaries created by age, gender, race, religion or political affiliation. Driven by the same spirit of service for others, volunteers from the Philippines and other countries work with local partners sharing expertise and technologies or enhancing indigenous ones toward building human resource capacities of self-governance, socio-economic employment and sustainable development.



The volunteers, composed of qualified and dedicated people offer a third workforce apart from the resources of the government and the corporate sector. The value of service they render creates a conducive environment for collaborative development work of the civil society.

### **3.0 Objectives**

- 3.1 Build nationwide public awareness and appreciation on the power of volunteerism and the role that it plays in the social, economic and political development of the country.
- 3.2 Create the environment for bolstering voluntary action in development.
- 3.3 Recognize the noble acts of volunteerism by individuals, families, institutions and communities as vital partners in economic and community development.

### **4.0 Strategies**

- 4.1 Intensive public information and education campaign to build awareness and generate support for volunteerism.
- 4.2 Promotion of volunteerism to decision-makers and program implementers in all sectors and at all levels for policy support and increased participation
- 4.3 Crafting of policy formulations to improve the policy environment for volunteerism in the country.
- 4.4 Mobilizing the entire citizenry for voluntary action.
- 4.5 Resource generation for volunteer programs and projects.
- 4.6 Network build-up among volunteers and volunteer organizations.
- 4.7 Monitoring and evaluation, documentation and dissemination of volunteer practices and experiences and establishment of database of volunteers with their expertise.
- 4.8 Recognizing acts of volunteerism by both the volunteers and the community.

## 5.0 Implementation Mechanism/Coordination of NVM

National and Regional Steering Committees composed of government agencies and non-government organizations shall be organized by PNVSCA to formulate the plan for the national celebration, disseminate said plan at all levels of government and the private sector, publicize the event and monitor the implementation of NVM activities.

The Committee shall be composed of the following:

Department of Budget and Management (DBM)

Department of Education (DepEd)

Filipino UNV Association (FUNVA)

Office of the President (OP)

Philippine Information Agency (PIA)

Philippine Association for Volunteer Effort (PAVE)

Technical Education and Skills Development Authority (TESDA)

Ugnayan ng Pahinungod System (UP)

United Nations Volunteers (UNV)

Voluntary Service Overseas (VSO)

One NGO Representative to be rotated every two years



## **6.0 Theme**

A national theme for the yearly celebration shall be adopted by the National Steering Committee but the Regional Steering Committees may choose their own sub-themes.

## **7.0 Coverage**

The celebration shall be undertaken nationwide and shall be spearheaded by leaders of local government units, national agencies of government, academic institutions, non-government organizations, people's organizations and community-based organizations at the national, regional, provincial, city, municipal and barangay levels. People participation will be of paramount concern.

## **8.0 Convergence, Monitoring and Evaluation**

Monitoring and evaluation will be conducted through reports and meetings. The Regional Steering Committees shall consolidate the various initiatives/activities in the regions for submission to the National Steering Committee for integration to the annual report of NVM and planning for succeeding celebrations.

## **9.0 Funding**


Funds for NVM activities will be sourced out from government and non-government entities.


## **10.0 Effectivity**


This implementing guideline shall take effect immediately. All agencies of government, non--government organizations, people organizations, the business sector, communities and individuals are enjoined to support the celebration.
