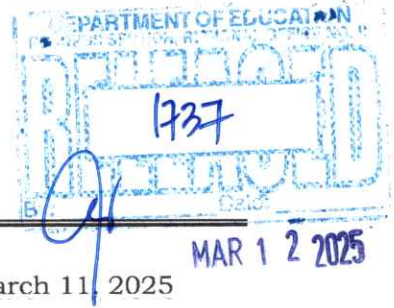

This program is aligned with the DepEd's 5-Point Agenda, specifically in ensuring the well-being of our learners and creating a safe and positive learning environment.
