

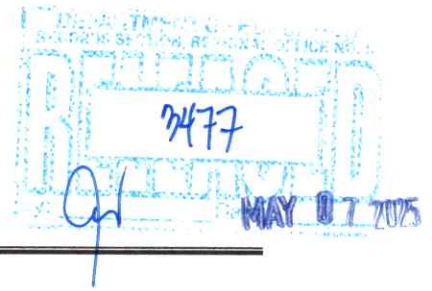

#### IMPLEMENTATION OF THE PHASE 2 – REVISED K TO 12 CURRICULUM TRAINING OF CORE FACULTY FOR GRADES 2, 3, 5, AND 8 TEACHERS AND SCHOOL LEADERS

To: All Schools Division Superintendents  
This Region

1. Pursuant to DM-OUHROD-2025-1100 signed by Undersecretary Wilfredo E. Cabral, the National Educators Academy of the Philippines (NEAP) shall conduct the Training of Core Faculty on the Implementation of the Phase 2 - Revised K to 12 Curriculum on May 15-17, 2025 at Baguio City.
2. The objectives and other details are stipulated in the enclosed memorandum.
3. The list of participants is enclosed. The participants shall bring their own laptops, chargers, extension cords, and other sources of internet connectivity.
