1. In line with the Department of Education's commitment to fostering equity and inclusivity, this office will conduct the Workshop on Gender-Responsive Planning and Sex-Disaggregated Data Management. The activity is scheduled on October 23-24, 2025 at DepEd NEAP-RIX, Tiguma, Pagadian City.
2. This is anchored on Republic Act No. 9710 or the Magna Carta of Women (MCW) which mandates all government agencies to adopt gender mainstreaming as a strategy to promote women's rights and eliminate gender-based discrimination and Joint Circular No. 2012-01 of DBM, NEDA, and PCW which sets the guidelines for the preparation of GAD Plans and Budgets and mandates the generation and use of sex-disaggregated data (SDD) as a basis for planning, budgeting, monitoring, and evaluating gender-responsive programs.
3. The workshop aims to:
  - a. Demonstrate the ability to collect, analyze, and interpret sex-disaggregated data to assess gender-related issues.
  - b. Develop GAD Plans and strategies that integrate gender-responsive approaches, supported by accurate and well-organized data management practices.
