All permits and licenses as may be required by any government agency in the execution of this Agreement for the establishment of the internet access shall be for the account of the Second Party.

In consideration of the Contract Price mentioned herein to be paid by the **First Party** to the **Second Party**, the **Second Party** hereby covenants, to the **First Party**, to provide the goods and ancillary services and to remedy defects therein in conformity in all aspects with the provisions of the Contract;
