**INVITATION FOR NEGOTIATED PROCUREMENT UNDER TWO FAILED BIDDINGS

 REGIONAL OFFICE IX SERVICE VEHICLES AND GENSETS**

1. The Department of Education Region IX intends to apply the sum of One Million Three Hundred Thousand Pesos (*Php 1,300,000.00*) being the ABC to payments under the contract for the Procurement of Service Provider for Fuel of DepEd Regional Office IX Service Vehicles and Gensets.
2. The Department of Education Region IX, through the Bids and Awards Committee (BAC) now invites technically, legally, and financially capable suppliers for the said project.
3. The Procurement procedure for this requirement is Negotiated Procurement under Two-Failed Bidding pursuant to Section 53.1 of 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.

The selection of the successful offer shall be based on the best and final offer that will be submitted on the set deadline by the BAC and which would meet the minimum technical specifications required.
